

Water Quality and You 2.0: Little Red Deer River

In 2024, Legacy focused on awareness and outreach through the <u>Water</u> <u>Quality and You 2.0 (WQY2.0)</u> program, funded by the Watershed Resiliency and Restoration Program.

This initiative, launched in 2022, promotes land stewardship practices along the Little Red Deer River and its tributaries, emphasizing the benefits of land conservation and conservation easements. A healthy sub-watershed creates drought resistance and flood mitigation while supporting wildlife habitats, water filtration, and soil stability.

WQY 2.0 Project Lead

Legacy welcomed Rose Chong-Wu back in 2024, this time as WQY2.0 Project Lead for a seven-month contract. Rose spearheaded initiatives including outreach to landowners on the Little Red Deer River and awareness-building through local events, Legacy's newsletter <u>Conservation News</u> and our social media channels.

Annual General Meeting

Our AGM on April 20th highlighted the theme of "water," featuring keynote speaker Kevin Van Tighem. His presentation—*Where Waters Come to Life: Headwater Landscapes of the Eastern Slopes*—emphasized the importance of private land conservation to preserve watershed health.

Executive Director continued ...

Paint, Pen & Pixels

Rose Chong-Wu and Legacy volunteer Nan McKernan collaborated on *Paint, Pen & Pixels.* This plein air art experience took place on the <u>Smith</u> <u>conservation easement</u> situated on the Little Red Deer River. The art created at the event was featured in a show at the Mountain View Museum and Archives in Olds from August 1st to September 15th.

Conservation Highlights

Legacy worked with the Mills family to place a 145-acre conservation easement on the south edge of Slack Slough, a 96-acre wetland and refuge for waterfowl located just south of Red Deer this spring. This project creates a buffer zone for the wetland and includes the potential for future trails and education initiatives around this vital wildlife resource in the Red Deer River watershed.

Anniversary Celebration

Legacy celebrated its 11th anniversary on October 19th at the Bergen Hall. Wildlife biologist and author Lorne Fitch shared readings from his newest book *Up the Creek – A Biologist's Search for a Paddle.* Volunteer Stories Coordinator Sarah Leach showcased two WQY2.0 program videos that can be <u>viewed on our website</u>

The value of Legacy Land Trust Society's Conservation Easements increased in 2024 to \$8,932,300 from \$7,999,300 at the end of 2023. Legacy's total net assets at the end of 2024 increased to \$10,551,869 from \$9,484,764 at the end of 2023. (Note that Conservation Easements comprising the bulk of these net assets reflect their book value and cannot be sold or borrowed against).

Endowment fund initial investment at year-end 2024 totalled \$512,620 comprised of \$480,000 (\$160,000 transferred from Legacy Dedicated Fund) invested in the Mawer Balanced Fund through a direct investment account with ATB Securities Inc. and \$237,620 (increase of \$45,000 contributed by Rotary related to the Slack Slough project) invested with the Community Foundation of Central Alberta (CFCAB).

The value of the ATB Direct Investment Endowment Account and the Smith Fund at year-end (December 31, 2024) was \$541,074 and \$16,894 respectively.

As per the terms of our Endowment Direct Investment Policy \$10,536 was withdrawn from the ATB Direct Investment Account to support monitoring and stewardship in 2024 and \$21,925 is available for 2025.

Revenues and Expenses were both higher in 2024 compared to 2023 (\$236,534 compared to \$196,113 and \$234,569 compared to \$196,475 respectively). Including unrealized gain on marketable securities, excess of revenue for 2024 was \$35,325 compared to \$12,738 in 2023.

Legacy's primary source of funding continues to be the Alberta Land Trust Grant Program (ALTGP). This Alberta government program is critical in allowing Legacy to collaborate with landowners to conserve conserve land with significant ecological, agricultural and heritage values.

The ALTGP was established under the Public Lands Act which places a portion of the proceeds from public land sales into a Land Stewardship Fund. ALTGP grants received by Legacy to date have been primarily for projects with ecological value. Funding for two projects (\$203,775) was received in 2024 based on applications submitted in September 2023. ALTGP funds are typically spent over a 2-to-3 year period. Unspent grant funding is restricted—these deferred contributions remain liabilities until spent.


Legacy had its second casino—and first in Calgary—on January 23rd and 24th, 2024. Revenue received totalled \$79,907. Legacy received approval from Alberta Gaming Liquor and Cannabis to use casino proceeds for monitoring and stewardship wages, opening the door to hiring a part-time Conservation Coordinator.

Legacy's Dedicated Fund balance as of December 31, 2024 was \$93,266. This consists of:

- \$35,500 earmarked to be transferred to Crooked Creek Conservancy Society of Athabasca to support monitoring and stewardship of the Amiscape CE,
- \$41,549 of unrestricted funds available to backstop future operating shortfalls, and
- \$16,217 waiting to be transferred to the ATB Direct Investment Endowment Account.



HIGHLIGHTS



- Conservation Easements for Landowners was revised and updated.
- Legacy worked with the Mills Family to place a CE on 145 acres along the south side of Slack Slough, a wetland refuge near Red Deer.



- Rose Chong-Wu became Project Lead for <u>Water</u> <u>Quality and You 2.0</u>, encouraging landowners along the Little Red Deer River to conserve their land.
- Conservationist and author of 15 books, Kevin Van Tighem gave the keynote presentation at the AGM.
- Seasonal Conservation Coordinators Zoe Montgomery and Ethan Sperle monitored Legacy's CEs.
 - 34 photographers donated images to the 2025 calendar.

- Volunteers and staff conducted the annual Buttercup Blitz on Owl Ridge, a CE near Water Valley.
- The second bluebird box on the Tribute Trail was dedicated to Harold Hadley.
- Legacy's Bluebird Trails fledged 97 Mountain Bluebirds and 147 Tree Swallows.
- Legacy rolled out its first membership campaign
- Staff and volunteers helped plant 540 shrubs and trees along an ephemeral watercourse in Bergen.
- Paint, Pen & Pixels was held on one of Legacy's CEs. Artwork and photos from the event were showcased at the Mountain View Museum & Archives.
- Volunteers and staff held an information booth at Neighbours' Day in Sundre.
- Legacy celebrated its 11th anniversary at the Bergen Hall, with wildlife biologist and author Lorne Fitch.



COMMITTEE REPORTS

Conservation Committee

Terry Antoniuk and Bruce Beattie, Co-Chairs

Role

The Conservation Committee advises on all matters related to conservation planning, conservation easements (CEs), and other land stewardship initiatives.

This includes responsibility for: reviewing and making recommendations on CE grant applications; and developing policy and guidance materials for securing and managing CEs.

Legacy works with private landowners and funders to select, secure, and manage conservation properties in Mountain View County and surrounding municipalities. Legacy now manages 16 Conservation Easements representing 3422 acres (547 ha).

Policy and Guidance

Over the last year the committee developed standards for property baseline reports and initiated discussions to refine annual monitoring protocols for existing CEs.

Activities

The committee's focus continues to focus on reviewing and making recommendations on proposed, pending and ongoing CEs.

During 2024 Legacy:

- Received funding from the Alberta Land Trust Grant Program (ALTGP) for 2 new CEs.
- Submitted applications to ALTGP for 1 potential CE with decision to come in early 2025.
- Finalized 1 CE with landowners.
- Identified 6 new potential CE opportunities, most by referral from Legacy volunteers, Friends, and CE holders.
- Completed monitoring on 14 Conservation Easements.
- Working to finalize 6 additional CEs.

Communications Committee

Sally Banks, Chair

Role

The committee guides, advises and supports the Board and the Executive Director on communications and outreach.

Strategic Plan

Awareness—growing community commitment to conservation easements—is a key goal under Legacy's Strategic Plan.

To help achieve that outcome, the committee began developing a Communications Plan in 2024. Work will continue in 2025. Terms of Reference will also be updated.

Governance Committee

Legacy's original Bylaws (circa 2013) were replaced by Special Resolution at the 2023 AGM. The Objects were replaced by Special Resolution at the 2024 AGM.

The following new polices were approved by the Board during 2024:

- Stewardship
- Volunteer Intake

The committee also updated the Endowment Direct Investment Policy and amended the Finance Committee's Terms of Reference, both of which were approved by the Board.

Going forward the committee will continue work on policies in progress and will develop and implement periodic review of approved polices and Terms of Reference.

Fundraising Committee

In 2024 Legacy had two main revenue streams the Alberta Government (Alberta Land Trust Grant Program and Watershed Resiliency and Restoration Program)—and *you*.

Thank you for your contributions. You invested in conservation when you

- joined our Stew Crew and became a monthly donor
- bought a copy of our annual Worth Conserving calendar
- became a Member
- made a one-time gift
- participated in our year-end campaign.

This year Legacy took part in the Dragon's Den hosted by the Rotary Club of Olds and was the recipient of \$1100! Total fundraising for 2024 was \$16,775 compared to \$29,889 for 2023.

Government and External Relations Lori-Jo Graham, Chair

The Government and External Relations Committee (GERC) provided Legacy's Board of Directors with guidance and advice regarding changes made to the Alberta Land Trust Grant Program (ALTGP) by the Government of Alberta.

ALTGP has traditionally opened grant applications each spring. That did not happen this year. (ALTGP is Legacy's only source of consistent funding for conservation easements.)

The <u>Regional Land Trust of Alberta</u> (RLTA)—of which Legacy is a member—engaged a government relations consultancy firm, Prairie Sky Strategy. The firm met with representatives of the ALTGP and the Alberta Government, to advocate for continued support of land trusts and perpetual conservation easements.

The committee provided support to RLTA's advocacy. In late September, ALTGP reopened for grant submissions. Several changes were made to the program including restricting eligible applicants to Alberta-based organizations.

The committee initiated two outreach activities. After a Mountain View County by-election, we reached out to newly elected Councillor Tiffany Nixon for an introductory meeting to be held early in 2025.

A request for a meeting was also sent to Nathan Cooper, Olds-Didsbury-Three Hills Member of the Legislative Assembly and Speaker of the Alberta Legislature.
